School Board Meeting –October 18, 2011 Regular Session

CALL TO ORDER AND ROLL CALL - 7:00 P.M.

ESTABLISH A QUORUM AND PLEDGE OF ALLEGIANCE

The Board of School Trustees of the John Glenn School Corporation met in regular session at 7:00 p.m. on October 18, 2011 in the John Glenn Administration Building. Board members present were Tom McCormick, Jeff Johnson, Dennis Holland, Janice Ryan, Mike Daube, and Bill Groves. Curt Pletcher was absent. Superintendent, Richard Reese, and eleven observers were also in attendance. The meeting began with the Pledge of Allegiance led by school board president Jeff Johnson.

RECOGNITIONS

Tim Davis, Principal of Walkerton Elementary School, congratulated the WES volleyball team for placing first in the annual sixth grade volleyball tournament. The team finished the season at 6-2. Deb Mosson was recognized for her efforts in organizing Red Ribbon Week. On Monday students and staff wore camouflage as they were encouraged to "win the war against drugs." Tuesday's theme was "give drugs the slip" and students and staff wore slippers. The different themes will continue throughout the week and prizes are given away every day along with other activities. The students and staff of WES were thanked for their donations to a family of a second grade student that experienced a house fire. The total donation amount, which included proceeds from Frozen Friday was \$414.50. The board was asked to accept the following donations: \$85 for WES cheerleading; and \$80 for the Moderate Classroom.

NEW BUSINESS

1. Approve Overnight Trip for FFA National Convention – October 19 – 21, 2011

Twelve FFA members are requesting to travel to the National FFA Convention in Indianapolis from October 19 - 21, 2011. Hannah Klopfenstein has been chosen to compete in the National Finals for Dairy Handlers Activity on Thursday, October 20, 2011.

2. Approve Overnight Trip for FFA Soil Judging Finals – October 27 – 29, 2011

The soils team would like to travel to Martinsville, IN to compete in the Indiana FFA State Soils Finals from October 27 - 29, 2011. This will be over fall break, so students will not be missing out on classes. This is the third consecutive year that the John Glenn team has qualified for the state finals soil judging. The team members are as follows: Betta McGaughey, Haley Verhaeghe, Victoria Morey, and Savhana Ciula. Alternates are Gretchen Keen and Alacyn Cox.

After a brief discussion, a motion was made by Tom McCormick, seconded by Bill Groves, to approve the overnight trip for the FFA Soil Judging finals on October 27 - 29, 2011. The motion was approved by a six to zero vote.

3. Review and Approve NLES Renovation

The school board was provided with six options for proposed additions at NLES along with reroute options for the drive. The options and respective prices are as follows: Option A, \$1,170,000; Option C-1, \$1,127,000; Option C-2, \$1,077,000; Option D, \$1,370,000 which also includes \$50,000 for the canopy cost; Option E, \$1,303,000; and Option F, \$1,180,000. Tom McCormick suggested that eight classrooms be added similar to scheme C-2 and that the rooms be moved over slightly. This would also include the addition of restrooms. The architect is going to take the information from the board and rework some of the drawings for the board to review.

The recommendation was made to renovate the media center and do the turnaround this year and add classrooms next year. Waiting for the addition of the classrooms would allow for more feedback. The approximate cost for the media center renovation is \$150,000 and for the turnaround is \$100,000 to \$150,000.

After a brief discussion, a motion was made by Bill Groves, seconded by Mike Daube, to approve the renovation of the media center and the turnaround at NLES using General Obligation Bonds for Board Meeting October 18, 2011 Page 4

funding. The motion was approved by a six to zero vote. A motion was made by Bill Groves, seconded by Mike Daube, to table the approval of the renovation to NLES adding classrooms. The motion was approved by a six to zero vote.
