#### School Board Meeting – November 15, 2011 Regular Session

#### CALL TO ORDER AND ROLL CALL - 7:00 P.M.

#### ESTABLISH A QUORUM AND PLEDGE OF ALLEGIANCE

The Board of School Trustees of the John Glenn School Corporation met in regular session at 7:00 p.m. on November 15, 2011 in the John Glenn Administration Building. Board members present were Tom McCormick, Jeff Johnson, Dennis Holland, Mike Daube, Curt Pletcher, Janice Ryan, and Bill Groves. Superintendent, Richard Reese, and ten observers were also in attendance. The meeting began with the Pledge of Allegiance led by school board president Jeff Johnson.

#### RECOGNITIONS

Tim Davis, Principal of Walkerton Elementary School, recognized the WES Spell Bowl Team as it will be traveling to NLES on November 17, 2011 to compete in the elementary version of the Hoosier Spell Bowl. The WES sixth grade basketball B team was congratulated for winning its first game against LaVille at the LaVille Pre-Season Tournament. The team lost to a very good Bremen team in the championship game. Everyone who helped make Veteran's Day a success at WES was thanked and are as follows: Vicky Tucker for organizing the program and providing a banner with a square from each classroom to the veterans; Cathy VanDuyne for leading the school in the National Anthem; Rosana Balmer for leading the school in the Pledge of Allegiance; and Commander Harl Shafer from VFW Post 1954 in North Liberty and the 12 veterans present to share the day with WES. Miller's Merry Manor was thanked for inviting the kindergarten class to trick-or-treat. All three classes, plus Miss Rizek's moderate class and Mrs. Snyder's pre-school class, went to Miller's Merry Manor and each student returned with candy to take home. The WES PTA and third grade teachers were recognized for providing dinner during parent-teacher conferences. This is a move to a higher class based on enrollment numbers and UMS was competing against schools with over 650 students enrolled. The team placed fifth. Mrs. Francie Beville, Mr. Damon Groves, Mrs. Jill Groves, Mrs. Donia Hudgen, and Mr. Seth Ponder were recognized for coordinating a Reality Store Program for eighth graders in the spring. The John Glenn Spell Bowl team was congratulated for earning the Division 2 State Spell Bowl Championship. The spellers won with a score of 84 out of 90, with the next closest score being 75. The team had four perfect 9/9 spelling rounds from Elly Alexander, Miranda Kafantaris, Kim Lord, and Holly Rowe. There were six near perfect spelling rounds of 8/0 from Jake Coday, Gabby Marek, Erin Patterson, Cole Jacobson, Ann Heckman-Davis, and JJ Silvey. This is John Glenn's 16<sup>th</sup> State Championship in the last 25 years and the teams third in Division 2. All fall sports have concluded and winter sports have started. The girls' basketball team had its home opener last week and the boys' basketball team starts next week. Wrestling starts Saturday with a JV Tournament at West Noble. The Fall Play, "A Christmas Carol" will be presented this weekend featuring 49 students from grades seven through twelve. General admission is \$6 at the door and the show is at 7:30 p.m. Friday and Saturday, and 2:00 p.m. on Sunday.

### OLD BUSINESS

1. Approve Board Policies and Bylaws

0160 Meetings

Policy 0161 contains a section titled "consent agenda," 0166.1 which requires the board to take action on purchases over \$2,000. Board policy 6320, "purchasing," which is included in your packet, states that the board needs to take action on purchases over \$5,000 and is currently what the board practices. To prevent conflicting statements, the item in policy 0160 will be removed referencing the need for board action for purchases over \$2,000.

After a brief discussion, a motion was made by Janice Ryan, seconded by Bill Groves, to approve board bylaw and policy 0160. The motion was approved by a seven to zero vote.

#### NEW BUSINESS

1. Review Plan for NLES Media Center Renovation and Turnaround

Dana Wannemacher from Barton Coe Vilamaa provided the board with three different approaches to the turnaround at NLES and the media center projected layout. Layout G1 created a loop and approximately 50 additional parking spaces that would eliminate three of the five tennis courts. Scheme G1 has an approximate cost of \$380,000. G2 would provide a rectangle turnaround and also approximately 50 additional parking spaces with the elimination of three tennis courts. G2 would create two lanes of traffic both flowing one way and its approximate cost is \$260,000. Layout H would create a driving loop that would connect with the street and also create approximately 50 additional parking spaces and eliminate three tennis courts. Scheme H would cost approximately \$420,000. The media center would include a new entry way, eliminate the current stair step area, and add lower level shelves for all elementary students.

2. Public Hearing Regarding Additional Appropriation

The public hearing was opened and no patrons stepped forward to speak. Randy Rompola from Baker and Daniels explained the process. On the board agenda for approval was the bond resolution authorizing an amount up to \$990,000. The resolution also set the parameters for the bond. The maximum interest rate is set at 6%. The appropriation resolution and it is appropriating the bond for the new project. A public hearing is required along with a notice that was previously published. The public hearing was closed.

3. Approve a Resolution of the John Glenn School Corporation Appropriating the Proceeds (Together with Investment Earnings Thereon) Derived from the Sale of General Obligation Bonds Heretofore Authorized

The appropriation resolution is in an amount not to exceed \$990,000.

After a brief discussion, a motion was made by Bill Groves, seconded by Janice Ryan, to approve a Resolution of the John Glenn School Corporation Appropriating the Proceeds (Together with Investment Earnings Thereon) Derived from the Sale of General Obligation Bonds Heretofore Authorized. The motion was approved by a seven to zero vote.

4. Approve a Resolution of the John Glenn School Corporation Authorizing the Issuance and Sale of General Obligation Bonds of the John Glenn School Corporation in an Aggregate Principal Amount Not to Exceed Nine Hundred Ninety Thousand and 00/100 dollars (\$990,000) to Procure Funds to be Applied to the Cost of Certain Renovations at North Liberty Elementary School, Together with Expenses Incidental Thereto, Including Expenses in Connection with Issuance of such Bonds

The bond resolution is in an amount not to exceed \$990,000.

After a brief discussion, a motion was made by Bill Groves, seconded by Mike Daube, to approve the Resolution of the John Glenn School Corporation Authorizing the Issuance and Sale of General Obligation Bonds of the John Glenn School Corporation in an Aggregate Principal Amount Not to Exceed Nine Hundred Ninety Thousand and 00/100 dollars (\$990,000) to Procure Funds to be Applied to the Cost of Certain Renovations at North Liberty Elementary School, Together with Expenses Incidental Thereto, Including Expenses in Connection with Issuance of such Bonds. The motion was approved by a seven to zero vote.
