### ESTABLISH A QUORUM AND PLEDGE OF ALLEGIANCE

The Board of School Trustees of the John Glenn School Corporation met in regular session at 7:00 p.m. on May 15, 2012 in the John Glenn Administration Building. Board members present were Jancie Ryan, Mike Daube, Jeff Johnson, Dennis Holland, Tom McCormick, and Curt Pletcher. Tom McCormick arrived at 7:05p .m. Bill Groves was absent. ## NEW BUSINESS

1. Approve Implementation of 1:1 Computer Initiative for UMS

The goal of the corporation is to implement a 1:1 computer initiative for the entire corporation. UMS will be the pilot school for the initiative to allow troubleshooting to occur on a smaller scale. The computers will be leased over a four year period and paid for through the CPF, Textbook Rental, and possibly TIF money.

After a brief discussion, a motion was made by Curt Pletcher, seconded by Janice Ryan, to approve curriculum the implementation of 1:1 computer initiative for UMS. The motion was approved by a six to zero vote.

2. Approve Purchase over \$5,000 – Technology Equipment for Special Education Classrooms

The corporation received a \$70,000 special education grant to be used in special education classrooms only. After collaboration with technology staff, students, parents, and educators, it has been determined that special education students would benefit from a more visual/auditory approach to instruction. Therefore, the recommendation was made to purchase iPads and the supporting hardware for special education instruction. A purchase of this nature can only come for Apple Computer, Inc. for a total cost of \$43,252.80.

After a brief discussion, a motion was made by Jeff Johnson, seconded by Mike Daube, to approve the purchase over \$5,000 of iPads in the amount of \$43,252.80 from Apple Computer, Inc. The motion was approved by a six to zero vote.

4. Approve Joint Service and Supply Fund Agreement for Special Education for the Joint Educational Services in Special Education

This is the final step in the JESSE Reorganization, which includes all information as it relates to personnel transfers, services districts, and processes of the reorganization.

After a brief discussion, a motion was made by Mike Daube, seconded by Jeff Johnson, to approve the Joint Service and Supply Fund Agreement for Special Education for the Joint Educational Services in Special Education. The motion was approved by a six to zero vote.

5. Approve JESSE Letters of Assurance for the 2012-13 School Year

Letters of assurance were sent out to all current JESSE employees informing them of JGCS's intent to employ them for the 2012-13 school year. The contracts for these new JGSC employees will be provided in August, as they are for all certified staff members.

After a brief discussion, a motion was made by Curt Pletcher, seconded by Jeff Johnson, to approve the JESSE letters of assurance for the 2012-13 school year. The motion was approved by a six to zero vote.

6. Approve Purchase over \$5,000 – UMS and JGHS Teacher Laptops

The JGSC 1:1 computer initiative requires that teachers are also familiar with the devices that will be provided to students. Teachers will need to be able to develop lesson plans and answer questions students have when using this technology. Quotes were received and it is recommended that 65 laptops be purchased from CDW-G for a total cost of \$32,825. This expense will be paid out of anticipated TIF money.

After a brief discussion, a motion was made by Jeff Johnson, seconded by Curt Pletcher, to approve the purchase over \$5,000 of \$65 laptops from CDW-G in the amount of \$32,825. The motion was approved by a six to zero vote.

7. Approve Purchase over \$5,000 – WES iPads

As part of the goal to provide mobile devices to every student, the purchase of iPads for grades K, first, and second at WES. In addition to the iPads, carts to charge, store, and transport them will be required, and a laptop to manage and sync the software. This type of purchase can only come directly from Apple. The amount to purchase 81 iPads and equipment is \$51,481.85. This purchase will be paid for out anticipated TIF Funds and WES technology CPF Funds.

After a brief discussion, a motion was made by Jeff Johnson, seconded by Dennis Holland, to approve the purchase over \$5,000 of 81 iPads from Apple Computer, Inc. in the amount of \$51,481.85. The motion was approved by a six to zero vote.
