2. Organize Board of Finance by Electing a President, Secretary, & Review of 2012 Investments

3. Approve Transfer of Appropriations of General Fund, Capital Projects Fund, and Transportation Fund

The superintendent stated that the budget is prepared 18 months in advance and Treasurer, Darlene Flora, does a great job anticipating how to allocate funds and keeping the amount of funds that need transferred to a minimum. Darlene Flora provided a brief explanation of the process involved with transferring appropriations.

After a brief discussion, a motion was made by Bill Groves, seconded by Jeff Johnson, to approve the transfer of appropriations of the General Fund, Capital Projects Fund, and Transportation Fund. The motion was approved by a seven to zero vote.

4. 2013 Costa Rica Trip – Spanish Class (Spring Break)

This New Business item has been put on hold until the February 5<sup>th</sup> board meeting.

5. Stipends for Support Staff

Richard Reese explained that this is a one-time stipend calculated at 1-1/2% of the base salary of support staff. A discussion was held concerning employees that have not completed their first full year of employment and their eligibility for the stipend. Dennis Holland recommended holding a discussion next year prior to any request for stipends.

A motion was made to approve the Stipends for Support Staff by Bill Groves, seconded by Jeff Johnson, and the motion passed with a seven to zero vote.

6. F.M.L.A. Leave for Olivia Hurley

Olivia Hurley, part-time custodian at Urey Middle School, requested a Family Medical Leave of Absence for six weeks following the birth of her child. Bill Groves made a motion to approve the F.M.L.A. leave for Ms. Hurley. Jeff Johnson seconded the motion, and the motion passed with a vote of seven to zero.

# **REPORTS**

1. Superintendent's Report

Mr. Reese provided the Board with zoning information regarding the new senior housing development in North Liberty.

Mr. Reese also reported on changes in the summer school structure for 2013. The high school will hold their first session starting on June 3 and ending June 28. The class times will run from 8:00 a.m. until 12:00 p.m. The second session will be for grades K-8, with some additional high school classes being offered as well. The second session will run from July 15 to August 2, 8:00 a.m. to 2:00 p.m. Bill Groves voiced his concern over the class times of the second session.

Mr. Reese asked Darlene Flora to discuss the 2013 Budget Order for 2013. Mrs. Flora provided the board with information on the Fund Report for 2013. A discussion was held concerning the Budget; Curt Pletcher explained alternative options that may be utilized in the future to help meet the budget.

Mr. Reese provided an update on the Intermodal Group. Promotional DVDs of John Glenn Schools will be provided to new prospective employers in the Kingsford Heights area. Janice Ryan stated that the John Glenn School Corporation is a big attraction for this intermodal development.

Mr. Reese and Mr. Davis attended a Safety Meeting at the Marshall County Sheriff's Department over winter break. Mr. Davis is the Safety Specialist for John Glenn School Corporation. Mr. Reese gave a brief summary of the meeting, and told the Board Members he would be willing to discuss safety issues at a future board meeting. Dennis Holland asked Mr. Reese and the administrators to meet and discuss future safety options; Curt Pletcher asked for a summary of any possible expenses that may be needed to upgrade security.
