# School Board Meeting – November 4, 2014 Regular & Executive Session

# CALL TO ORDER AND ROLL CALL – 7:00 P.M.

#### ESTABLISH A QUORUM AND PLEDGE OF ALLEGIANCE

The Board of School Trustees of the John Glenn School Corporation met in regular session on November 4, 2014 at the John Glenn Administration Building. Board members present were Dennis Holland, Jeff Johnson, Tom McCormick, Janice Ryan, Curt Pletcher, Bob Borlik, and Bill Groves. Richard Reese, Superintendent, and four observers were also present.

# RECOGNITIONS (WES, NLES, UMS, JGHS)

Parent/Teacher conferences were held Wednesday and Thursday, October 21st and 22nd at Walkerton Elementary. Conferences were well attended with the percentage of parents attending for each grade level as follows: Kindergarten – 96%; First Grade – 97%; Second Grade – 98%; Third Grade - 93%; Fourth Grade - 84%; Fifth Grade - 92%; Sixth Grade - 82%; Resource - 90%. Student participation during Red Ribbon Week was recognized by Mr. Tim Davis. Students had a great time dressing up to 'stomp out drugs' (wear boots); 'Drugs can't find me' (Camouflage day); Put a Lid on Drugs (Hat day); and 'Wear Red Day'. Mrs. Kaser and Mr. Hannah, along with Mr. and Mrs. Winchell, recently hosted a 6<sup>th</sup> Grade Fall Party. The 6<sup>th</sup> graders decorated the front of the school, went on a Hayride, and celebrated at JGHS with a bon fire. Mr. Reese and Board Members were invited to attend Walkerton Elementary Veteran's Day Program on Tuesday, November 11, beginning at 9:00 a.m. Mr. Ryan Reese, Mr. Matt Malstaff and Mr. John Schmidt were recognized for their efforts in organizing a 'Lock In' on Friday, October 17<sup>th</sup> for all students in grades K-6.
