School Board Meeting – December 16, 2014 Regular & Executive Session

CALL TO ORDER AND ROLL CALL – 7:00 P.M.

ESTABLISH A QUORUM AND PLEDGE OF ALLEGIANCE

The Board of School Trustees of the John Glenn School Corporation met in regular session on December 16, 2014 at the John Glenn Administration Building. Board members present were Jeff Johnson, Janice Ryan, Curt Pletcher, Dennis Holland, and Bill Groves. Tom McCormick and Bob Borlik were absent. Richard Reese, Superintendent, and nine observers were also present.

RECOGNITIONS (WES, NLES, UMS, JGHS)

Mrs. Cathy Van Duyne was recognized for putting together a wonderful Christmas program at Walkerton Elementary on Thursday, December 11th. The program was called "Celebration of Sounds," with all students in grades four through six participating. Mr. Tim Davis, Principal, thanked area businesses, as well as many individuals, for graciously adopting a family during WES's annual Adopt-A-Family program. There were 50 families adopted this year which included 126 children. Mrs. Jodi Park's effort in organizing this annual event for WES was highlighted, as well as three PTA volunteers, Mrs. Raquel Snyder, Mrs. Treasure Geers, and Mrs. Dawn Rensberger, who helped distribute gifts. The JGHS Boys' and Girls' Basketball teams recently took several WES students shopping at Walmart as part of the Adopt-A-Family Program. WES Student Council members participated in the Festival of Trees at Miller's Merry Manor this year, while Resource students, Preschool students, and Ms. Rizek's students made ornaments for one of the trees at Miller's. Eight students in Mrs. Perry's First Grade classroom have already won free Deep River Water Park tickets for Reading 360 minutes.
