# School Board Meeting – September 2, 2014 Regular & Executive Session

# CALL TO ORDER AND ROLL CALL - 7:00 P.M.

## ESTABLISH A QUORUM AND PLEDGE OF ALLEGIANCE

The Board of School Trustees of the John Glenn School Corporation met on September 2, 2014 at the John Glenn Administration Building. Board members present were Dennis Holland, Bob Borlik, Jeff Johnson, Tom McCormick, Janice Ryan, Curt Pletcher and Bill Groves. Richard Reese, Superintendent, and five observers were also present.

It is now possible to refinance the 2004/2005 Bonds from the high school renovation. Rates are lower, which will generate enough funds to allow some projects to be completed at the high school. Because the funds are coming from the 2004/05 high school bonds, all funds must be spent at the high school. Anticipated projects include outdoor track renovation and a soccer field project. Janice Ryan made a motion to approve the Preliminary Approval of Proceeding with a Refunding of Certain Maturities of the 2004-2005 Bonds. Jeff Johnson seconded the motion, and the motion passed with a vote of seven to zero.
