School Board Meeting – March 18, 2014 Regular Session

CALL TO ORDER AND ROLL CALL - 7:00 P.M.

ESTABLISH A QUORUM AND PLEDGE OF ALLEGIANCE

The Board of School Trustees of the John Glenn School Corporation met in regular session at 7:00 p.m. on March 18, 2014, at the John Glenn Administration Building. Board members present were Dennis Holland, Tom McCormick, Janice Ryan, and Bill Groves. Jeff Johnson, Bob Borlik, and Curt Pletcher were absent. Richard Reese, Superintendent, and nine observers were also present.

The high school cafeteria is in need of a new booster heater for the dishwasher. Two quotes were presented to the Board for consideration. A short discussion was held before Janice Ryan made a motion

to approve the purchase of the Booster Heater from Stanz for \$6,010. Dennis Holland seconded the motion, and the motion was approved with a vote of four to zero.

 - a) Balanced Calendar Meetings Update

Two public meetings were held to provide information about the balanced calendar to parents and the general public. Surveys were completed by all in attendance and this information was compiled and presented to the board.
