# School Board Meeting - June 3, 2014 <br> Regular Session 

CALL TO ORDER AND ROLL CALL - 7:00 P.M.

## ESTABLISH A QUORUM AND PLEDGE OF ALLEGIANCE

The Board of School Trustees of the John Glenn School Corporation met on June 3, 2014 at 7:00 p.m. at the John Glenn Administration Building. Board members present were Dennis Holland, Janice Ryan, Jeff Johnson, Bob Borlik, Curt Pletcher, Tom McCormick, and Bill Groves. Richard Reese, Superintendent, and 15 observers were also present.

Mr. Davis of Walkerton Elementary School provided the $4^{\text {th }}$ nine-weeks honor roll to the Board for review. There were 41 students with perfect attendance for the entire school year; each of these students received a t-shirt commemorating their accomplishment. The fifth grade students recently competed in the "Sumdog US National Math Contest" and earned the top spot in the county after answering 329 questions correctly. Sarah Wolff was named Honorable Mention All-Conference in Girls’ Tennis, and the Boys' Golf Team won the NSC Tournament on May $24^{\text {th }}$. Sydney Carson recently competed in the International Shooting Sport Federation (ISSF) Junior Cup, in Suhl, German.

Sydney was a member of the USA Skeet Shooting Team which earned a gold medal, and Sydney earned an individual gold medal as well.
