# School Board Meeting – August 5, 2014 Regular Session

# CALL TO ORDER AND ROLL CALL – 7:00 P.M.

### ESTABLISH A QUORUM AND PLEDGE OF ALLEGIANCE

The Board of School Trustees of the John Glenn School Corporation met on August 5, 2014 at Walkerton Elementary School at 6:30 p.m. to view the renovated classrooms. The Board Members then met at 7:00 p.m. at the John Glenn Administration Building. Board members present were Curt Pletcher, Bill Groves, Dennis Holland, Bob Borlik, and Tom McCormick. Janice Ryan and Jeff Johnson were absent. Richard Reese, Superintendent, and 14 observers were also present.

# **PUBLIC RESPONSE**

Steve Bruski, father of 2010 John Glenn graduate Savanna Bruski, donated framed artwork to the School Corporation. Mr. Bruski's donation was made to recognize the outstanding efforts of the staff at the middle school and high school for the fine education his daughter received. Mr. Bruski announced that Savanna will be entering med-school in the fall.

Mr. Morton asked the Board to accept several donations to John Glenn High School. North Liberty Elementary donated \$200 to Girls' Basketball. # **NEW BUSINESS**

### 1. Approve Student Handbook Changes - John Glenn High School

Chris Winchell reviewed with the Board changes to the John Glenn High School student handbook before Curt Pletcher made a motion to approve the changes as presented to the 2014-2015 John Glenn High School Student Handbook. Tom McCormick seconded the motion, and the motion passed with a vote of five to zero.

### 2. Approve French and Spanish Curriculum Changes – John Glenn High School

Chris Winchell explained the curriculum changes presented to the Board for approval. Curt Pletcher made a motion to approve the French and Spanish curriculum changes, and Dennis Holland seconded the motion. The motion passed with a vote of five to zero.

#### 3. Approve the Maximum Number of Transfer Students

Richard Reese highlighted the requirements set forth by the Department of Education concerning transfer students. The DOE requires each school to annually set a limit on the number of students the corporation will accept. A short discussion was held before it was decided to set the limit at 30 students per grade level, per school. Bob Borlik made a motion to approve the maximum number of transfer students allowed at 30 students per grade level. Tom McCormick seconded the motion, and the motion passed with a vote of five to zero.

### 4. Approve Purchase Over \$5,000 – North Liberty Chrome Books

A short discussion was held before Curt Pletcher made a motion to approve the purchase of 325 Chromebooks and four charge carts for \$90,950 from CDW. Dennis Holland seconded the motion, and the motion passed with a vote of five to zero.
