# School Board Meeting - October 20, 2015 Regular \& Executive Session 

## CALL TO ORDER AND ROLL CALL - 7:00 P.M.

## ESTABLISH A QUORUM AND PLEDGE OF ALLEGIANCE

The Board of School Trustees of the John Glenn School Corporation met in regular session at 7:00 p.m. on October 20, 2015, at the John Glenn Administration Building. Board members present were Jeff Johnson, Dennis Holland, Tom McCormick, Bob Borlik, and Janice Ryan. Curt Pletcher and Bill Groves were absent. Richard Reese, Superintendent, and three observers were also present.

## RECOGNITIONS (WES, NLES, UMS, JGHS)

Mrs. Rebecca Cummings, Assistant Principal for Walkerton Elementary Principal, asked the Board to accept the following donations: Falcon 500-\$88 to WES for B.B. paper; Falcon 500-\$89 to Minds in Motion room for a Bosu Ball; and Feed the Children Free Teacher Store - Pallet of Candy. The Polk Township and Lincoln Township Firefighters were thanked for their time spent with WES kindergarten classes as students traveled to the Lincoln Township fire station where they were instructed on fire safety. The Polk township firefighters came to the school on Friday, October 9th and spoke to all students in grades K-6. WES had 237 students with perfect attendance for the first nine-week grading period. WES had an attendance rate of $97.64 \%$ for the first 9 weeks. On Saturday, October 11th, the $6^{\text {th }}$ Grade Volleyball Wildcats defeated Laville in the first round of the tournament they competed in, but lost to Knox in the championship round. North Liberty Elementary PTO and 6th grade Student Council members were recognized for planning and coordinating this wonderful celebration. The 1st grading period honor roll was presented to the Board for review.

Urey Middle School seventh graders, Maya Vermillion and Samuel Thomas and eighth graders, Martin Malec and Abby Machnic were named September Students of the Month. Seventh graders, Chloe Martin and Nathan May and eighth graders, Brennen Boley and Emily Neyhart were named October Students of the Month.

Mr. Robert Gendron, PLTW Instructor, submitted a request for the purchase of a 3-D printer and laser engraver for the Project Lead the Way classroom at a total purchase price of $\$ 29,899$. A short discussion was held concerning the purchase of this equipment before Janice Ryan made a motion to approve the purchase of the PLTW 3-D printer and laser engraver at a total price of $\$ 29,899$. Dennis Holland seconded the motion, and the motion passed with a vote of five to zero. The cost of these items will be paid from the refinancing of the high school bonds.

Mr. Richard Reese, Superintendent, updated the Board on the progress being made on the practice football and soccer fields. Mr. Reese noted that bids for the new soccer field will be taken by December $1^{\text {st }}$, with a projected start time in March of 2016.

The Department has predicted that students' scores will decline this next year due to changes in testing format and increased standards requirements. Mr. Reese stated he will provide more information to the Board, as well as parents, when the testing results release date draws near.
