# School Board Meeting - May 17, 2016 Regular Session 

CALL TO ORDER AND ROLL CALL - 7:00 P.M.

## ESTABLISH A QUORUM AND PLEDGE OF ALLEGIANCE

The Board of School Trustees of the John Glenn School Corporation met in regular session at 7:00 p.m. on May 17, 2016, at the John Glenn Administration Building. Board members present were Janice Ryan, Jeff Johnson, Tom McCormick, Bob Borlik, Dennis Holland, and Curt Pletcher. Bill Groves was absent. Richard Reese, Superintendent, and six observers were also present.

## RECOGNITIONS (WES, NLES, UMS, JGHS)

Mr. Tim Davis, Walkerton Elementary Principal, invited Superintendent Mr. Reese and all Board members to the Annual Sixth Grade Celebration, which will be held on Tuesday, May 24, 2016, at 6:30 pm. Mr. Davis also invited the Board to WES' Spring Music Program on Thursday, May 19, 2016, at 7:00 p.m. Mrs. Cathy Van Duyne and students in Grades Four, Five, and Six will perform "Best Self, Best Work, Best World." Mr. Davis recognized the WES PTA for all the hard work done to assist WES students and staff during the 2015-2016 school year. The WES Third Annual PTA Fun Fair will be Friday, May 20, 2016 and will run from 5:30 to 8:00 p.m. Mr. Davis provided to the Board information for the WES Summer Reading Challenge, and Ms. Jen Carr, John Glenn High School Physical Education Teacher, and her students from Adaptive PE, were recognized for their excellence in planning activities for students in an inclusive setting. ## NEW BUSINESS

1. Approve Second Reading of Special NEOLA Policy Updates

Janice Ryan made a motion to approve the second reading of the special NEOLA policy updates. The motion was seconded by Jeff Johnson, and the motion passed with a vote of six to zero.

## 2. Approve Purchase Request of Soccer Scoreboard

Mr. Chris Manering, Athletic Director, recommended purchase of a soccer field scoreboard, with financial sponsorship of the scoreboard coming from "The Zone", Plymouth. Over the course of one to three years, The Zone will make payments to John Glenn School Corporation for the scoreboard. Purchase price of the scoreboard will be $\$ 11,936.42$ and will be purchased from Nevco. After a short
discussion, Jeff Johnson made a motion to approve the purchase of the soccer scoreboard for $\$ 11,936.42$ from Nevco. Dennis Holland seconded the motion, and the motion passed with a vote of six to zero.
3. Approve Payment of $\$ 32,955.27$ to the John Glenn School Corporation from the Building Fund

This amount has already been spent on the soccer field, however this is the formal process required to get reimbursement. Mr. Tom Bendy, Treasurer, advised the Board this is the most efficient way to complete the transaction. Janice Ryan made a motion to approve payment of $\$ 32,955.27$ to JGSC from the Building Construction Fund. Jeff Johnson seconded the motion, and the motion passed with a vote of six to zero.

## 4. Approve UMS Student Handbook

Jeff Johnson made a motion to approve the UMS Student Handbook revisions. Dennis Holland seconded the motion, and the motion passed with a vote of six to zero.
5. Approve John Glenn School Corporation's Agreement with Crossing National, Inc (the "Crossing").

The Crossing is an alternative school that deals with students who have either been expelled or have dropped out of school. The Crossings provides great services to encourage students to graduate from high school. Curt Pletcher made a motion to approve the agreement between John Glenn School Corporation and The Crossings, and Tom McCormick seconded the motion. The motion passed with a vote of six to zero.
