# School Board Meeting – September 4, 2018 Regular Session

# CALL TO ORDER AND ROLL CALL - 7:00 P.M.

The Board of School Trustees of the John Glenn School Corporation met in regular session at 7:00 p.m. on September 4, 2018, at the John Glenn Administration Office. Richard Reese, Superintendent, and ten observers were also present.

4. Transfer Student Requests

As of Friday, August 31, 2018, there were 440 requests for transfer into the John Glenn School Corporation. The Board was presented with one new request for approval: Cameron Tiffany, NLES, 3<sup>rd</sup> grade.

Bob Borlik made a motion to approve Consent Agenda Items one through four and Dennis Holland seconded the motion. The motion passed with a six to zero vote.

### NEW BUSINESS

1. Approve the Maximum Number of Transfer Students and Deadline for Transfer

A lengthy discussion was held to determine the appropriate allowable number of transfer students for the 2018-2019 school year. Jeff Johnson made a motion to accept 45 transfer students per grade level, a total of 585 students, for the 2018-2019 school year. In addition, the motion included the application deadline of May 25, 2019. Christian Mattix seconded the motion, and the motion passed with a vote of six to zero.

2. Approve FMLA Paperwork for Employees 1991 and 3037

Jeff Johnson made a motion to approve the FMLA requests for employees 1991 and 3037. Dennis Holland seconded the motion, and the motion passed with a six to zero vote.

3. Approve Advertising for the 2019 Capital Projects Plan and Bus Replacement Fund

Mr. Tom Bendy, Treasurer, noted that the 2019 Capital Projects Plan and the 2019 Bus Replacement Fund will be published one time in the Plymouth Pilot and the South Bend Tribune on September 11, 2018. The Bus Replacement Plan and CPF Plan will be posted on the school website for review. Mr. Bendy further noted that Form 3 will be submitted on Gateway by September 18<sup>th</sup>. Bob Borlik made a motion to approve advertising for the 2019 Capital Projects Plan and Bus Replacement Fund. Jeff Johnson seconded the motion, and the motion passed with a vote of six to zero.

4. 2019 Budget Discussion – Mr. Tom Bendy

Mr. Bendy reviewed with the Board generalities about the 2019 budget. Mr. Bendy stated he will ask for adoption of the 2019 budget at the October 16, 2018 meeting. Mr. Bendy reviewed new changes coming to the financial funds of the corporation, per state legislation, and announced that the advertised tax rate will be \$1.317, the advertised levy will be \$4,806,881, and the total budget amount for 2019 is \$18,140,292.

## **REPORTS**

1. Superintendent's Report

Mr. Richard Reese, Superintendent, announced that Dan Drotar, Dennis Holland (incumbent), and Bill Groves (incumbent) will be running unopposed for the three board positions up for renewal. Long-time member Janice Ryan will retire the end of December.

Mr. Reese notified board members of an upcoming project in North Liberty, which will require survey crews to work along the North Liberty Elementary property line.

Board members discussed possible dates and times to review applications received for the upcoming Superintendent vacancy.
