# School Board Meeting - November 6, 2018 <br> Regular Session 

## CALL TO ORDER AND ROLL CALL - 7:00 P.M.

## ESTABLISH A QUORUM AND PLEDGE OF ALLEGIANCE

The Board of School Trustees of the John Glenn School Corporation met in regular session at 7:00 p.m. on November 6, 2018, at the John Glenn Administration Office. Board members present were Jeff Johnson, Curt Pletcher, Christian Mattix, Bill Groves, Bob Borlik, and Janice Ryan. Dennis Holland was absent. Richard Reese, Superintendent, and six observers were also present.

Mr. Tim Davis, Walkerton Elementary Principal, asked the Board to accept the following donations:

Bill Groves made a motion to approve Consent Agenda Items one through four and Bob Borlik seconded the motion. The motion passed with a six to zero vote.

## NEW BUSINESS

1. Approve Two Year Snow Removal Contract with Scotty's Ventures 2018-2020

Mr. Richard Reese, Superintendent, informed the Board the rates for snow removal have not increased since 2010, and Scotty's Ventures is willing to continue with the prices stated in the 2010 contract. Mr. Reese stated that the corporation has a great working relationship with Jeremy Helmholdt, Owner, and his staff.

Bill Groves made a motion to approve the Two Year Snow Removal Contract with Scotty's Ventures for the winter seasons 2018-2019 and 2019-2020 as presented, and Christian Mattix seconded the motion. The motion passed with a six to zero vote.

## 2. Approve Naming Rights Agreement - Teacher's Credit Union

Mr. Reese presented the key points of the agreement, which include:

- TCU will be giving the Corporation $\$ 15,000$ per year over the next five years.
- TCU will give the Corporation a bonus dividend of $.20 \%$ on February $1^{\text {st }}$ of each year based on the corporation's Operating Account average balance for the previous year (approximately $\$ 4,500$ to $\$ 5,000$ ). The bonus dividend is an additional contribution for the next five years.
- TCU will have exclusive rights and sponsorship of Falloween and the Senior Top Ten Percent Banquet. It does not mean that others cannot sponsor these events, but TCU will be the primary sponsor for those events.
- In addition, if any other financial institution wants to name a specific room in one of the buildings, such as cafeteria or auditorium, they would have to offer the Corporation the same amount of money as what TCU offers.

Mr. Reese noted that this agreement has worked out very well for the Corporation in the past, and the amount of money that TCU donates helps our students tremendously. Bill Groves made a motion to approve the Five-year Naming Rights Agreement with Teacher's Credit Union. Curt Pletcher seconded the motion, and the motion passed with a vote of six to zero.

Mr. Reese reviewed with the Board key details of the North Liberty Walking Trail project, noting that the walking trail will follow along the property line of North Liberty Elementary School. A short discussion was held concerning the project.
