NEW BUSINESS

1. Approve Purchase over \$10,000 for Phone System Upgrade

Andy Stegemiller, Technology Director, requested board approval for the purchase of a new phone system for the corporation. The current phone system, which is outdated, will not last much longer. Mr. Stegemiller obtained three quotes for the Board's review. His recommendation is to purchase from ENA at an upfront cost of \$21,980, with a monthly cost of \$1,918.51. Mr. Chris Winchell, Superintendent, noted that Treasurer, Tom Bendy, has already worked the cost of the new phone system in the budget. A

short discussion was held before Jeff Johnson made a motion to approve the purchase of a new phone system for the Corporation from ENA for \$21,980 upfront costs and \$1,918.51 monthly charges. Bill Groves seconded the motion, and the motion passed with a vote of five to zero.

2. Approve Purchase over \$10,000 for Special Purpose Bus

Marie Fansler, Transportation Director, requested approval for the purchase of a "special purpose" bus from Midwest Transit Equipment for \$50,559. This is a 2018, 14-passenger bus with a gasoline engine. Mr. Winchell reviewed specs with the Board before Bill Groves made a motion to approve the purchase of a 2018, 14-passenger bus from Midwest Transit Equipment for \$50,559. Jeff Johnson seconded the motion, and the motion passed with a vote of five to zero.

3. Approve JGHS Speech Team Overnight Trip to Noblesville on Friday, March 13, 2020

Speech Team Sponsor, Jennifer Moore, asked for approval of this tentative request in the event the team makes it to the state finals, which will be held on Friday, March 13 and Saturday, March 14, 2020. The finals will take place in Fishers, Indiana. Bill Groves made a motion to approve the Speech Team overnight trip to Noblesville on Friday, March 13 2020. Dan Drotar seconded the motion, and the motion passed with a vote of five to zero.
